A RESOLUTION TO RECOGNIZE THE CREATION OF THE YOUTH  
SERVICES DIVISION WITHIN THE SANTA FE COUNTY COMMUNITY  
SERVICES DEPARTMENT

---

**WHEREAS**, a healthy community is a key goal for Santa Fe County (“County”); and

**WHEREAS**, in 2014, the Board of County Commissioners (“Board”) approved the *Santa Fe County Health Action Plan* recommended by the Santa Fe County Health Policy and Planning Commission and the Santa Fe County Community Services Department; and

**WHEREAS**, the *Santa Fe County Health Action Plan* establishes behavioral health as a priority, including reducing drug abuse, reducing alcohol abuse, and reducing suicides; and

**WHEREAS**, the Santa Fe County Community Service Department developed a Behavioral Health Strategic Plan that recommended the County develop behavioral health programming for youth; and

**WHEREAS**, in 2019, 41.6 percent of youth in Santa Fe County in grades 9-12 reported persistent feelings of sadness and hopelessness over the past year; and

**WHEREAS**, in 2019, 18.9 percent of youth in Santa Fe County reported seriously considering suicide;

**WHEREAS**, the Santa Fe Public Schools and other community organizations have observed increased feelings of alienation and depression in youth since the onset of the COVID-19 pandemic; and

**WHEREAS**, the Board has over the years prioritized and funded youth services, including a Teen Court program, substance abuse prevention programs, and youth education and recreation; and

**WHEREAS**, in 2018, the Santa Fe County Strategic Plan confirmed the need for a Youth Services Division within the Community Services Department, to streamline and create services for youth.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of County Commissioners of Santa Fe County recognizes the:

- a. Consolidation of the youth-related services and funding streams, including those of the Teen Court and DWI programs, into a Youth Services Division within the Community Services Department. This had no budgetary impact.
- b. Partnering with entities of like interest and other community stakeholders to develop a strategic plan outlining the needs of youth in Santa Fe County and offer recommendations.
- c. Streamlining youth education, recreation and behavioral health funding to develop a comprehensive system of evidence-based services to meet the health and social welfare of youth in Santa Fe County.
- d. Reporting on the status of youth health, as well as on all Santa Fe County efforts to serve youth, on an annual basis to the Board.
