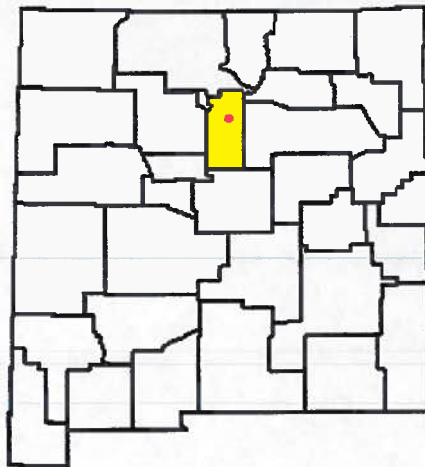

Santa Fe ([Spanish](#), "Holy Faith"; full form: La Villa Real de la Santa Fé de San Francisco de Asís, [English](#): Royal City of the Holy Faith of [St. Francis of Assisi](#)) is the largest city and the [county seat](#) of [Santa Fe County](#). The City of Santa Fe had a population of 67,947 at the [2010 census](#). It is the principal city of the Santa Fe, New Mexico [Metropolitan Statistical Area](#) which encompasses all of Santa Fe County. The elevation of Santa Fe is nearly 7,000 feet (2,100 meters) above [sea level](#) compared with approximately 5,352 ft (1,600 m) for nearby [Albuquerque](#).
